Requirements for Al Koran Membership

Eligibility - A candidate must be a Master Mason in good standing

Dues - Annual dues are made up of the Temple Dues of \$117.00 plus the Imperial Per Capita of \$15.00 and a Mandatory Assessment of \$5.00 for the Shriners Hospitals for Children and the Shriners Burns Institutes for a total of \$137.00 per year.

*Nobles who are top line signers and attend the ceremonial with their candidates are exempt from dues in 2016.

General Information

Shrine Ceremonials are usually held on Saturdays and a schedule of events is provided prior to the ceremonial. Ceremonials may be held at other times at the call of the Potentate.

There is no memorization or exam required after the initiation and conferral of the work.

During Ceremonials, candidates are escorted at all times and are in the care of experienced committees.

Cleveland's Al Koran Temple

Al Koran Temple is the fourth oldest temple with a charter dating back to 1877. We currently have 1,300 members. Al Koran was founded in 1877 by Samuel Briggs. He and Brenton D. Babcock were made Nobles by William J. Florence, founder of the Shrine of North America, on October 21, 1876.
