It is official! We have a signed agreement to establish a hospital within a hospital at Dayton children's Hospital, Dayton Ohio. This is an exciting time and helps us continue to care for burn, plastic and reconstructive surgery patients. The most important thing is that we are still in the same geography and will continue to change and save children's lives, in the end that is our mission. Healthcare has undergone tremendous change since SHC-Cincinnati was established. A shift towards outpatient care, telemedicine, and a steady decline in the severity and number of pediatric burns in the USA, especially those requiring a long hospital stay make this change necessary. Located one hour north of our existing location, Dayton Children's Hospital will provide an outstanding array of services to include all services presently provided at SHC-Cincinnati. Dedicated NICU and surgery suites are being constructed along with inpatient facilities that are state of the art. With the true spirit of cooperation, the Dayton Children's Hospital will also provide in-house services such as laboratory, pharmacy, imaging, and other services required to deliver our brand of exceptional care. We expect the transition to occur in late 2020. In the interim, our facility in Cincinnati will remain open during construction, we will continue to provide exceptional care at the Cincinnati location, and we continue to accept new patients during this time. ### **PATIENT EXPERIENCE: OCUPATIONAL THERAPY**

One of the key parts of the occupational therapists' work at Shriners Hospitals for Children - Erie is helping to make feeding and eating positive experiences for our kids and their families. One of the first feeding clinic patients that Stephanie Mbouck, occupational therapist, worked with at SHC - Erie is Anthony. Anthony came to us as an 8 year old patient whose mealtime consisted of drinking PediaSure, eating yogurt and occasionally other pureed type foods such as mashed potatoes. The smells, tastes and textures of food made him gag easily and refuse to participate in mealtime. He had decreased ability to chew and maneuver foods in his mouth because it had been years before he actually had these experiences.

Over the past two years, Anthony has worked on his tolerance for eating different textures of food and moving food around his mouth to chew and swallow efficiently. It has been a long process and typically, due to his age and learned behaviors, it would be difficult to make a lot of change with eating habits and food preferences. Anthony, however, has made tremendous gains in eating and has been a huge success. Anthony enjoys eating very difficult textures of food such as sandwiches and cheeseburgers now. He is starting to expand his flavors. He has started eating tomato soup with his grilled cheese. He is now able to join in with the family during mealtimes.

Anthony will be discharged in the next few weeks due to his amazing gains. His family works with him daily to continue to make the changes at home and expand



nutritious foods. He has a great sense of humor and enjoyed answering questions from the Shrine Vine:

Pittsburgh Penguins and Pittsburgh Steelers.

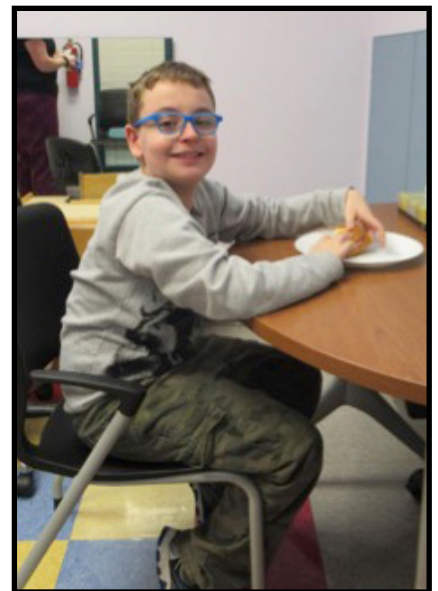
***If you could be anyone in a movie, who would you be?***

January has made its escape and into the history books with a most successful Installation of Al Koran Officers for 2020, I offer my congratulations to those who have been elected and appointed to serve this great organization, please do not hesitate to call on me if I can assist you in any way. Winter has not been too terrible but February and March may be a different story. Nobles, Lodge inspections around our jurisdiction have stated and if you have not attended your Lodge in recent years please make a visit. Al Koran has started another interesting year with many planned activities for you and your families please watch the future issues of our magazine for details and plan to attend.

Nobles, the 2020 dues statements have been mailed from Tampa and if you have not received yours please give me a call in the office, I have been informed several have NOT received a dues statement if you are one please give me a call in the office and I will mail you one if needed, I will do my best to get them to you quickly. There are still 225 who have not paid 2020 dues. You do not need your statement to pay

your dues, they remain at \$137.00, you can send them to my attention in the office, please include your member number on check. The 2020 dues card stickers are also being sent from Tampa and should be arriving to those who have paid their dues shortly, if you do not have a plastic card call me in the office and I can order a replacement. Al Koran does not have these cards; both these items were provided by Imperial to help all Shrine Centers save postage costs. There are 195 Shrine Centers in USA and over 250,000 members so it is a great effort to make sure the statements, cards and stickers are sent correctly and they rely on the Records to provide correct information. I have received several back via return mail which was sent to the address on file, if you have moved or are a snowbird, please inform me of your new address and also address of your winter months so communications are not lost, thank you in advance for complying.

As 2019 concludes the annual reports were filed and some interesting facts about Al Koran. We started the 2019 year with 1,009 regular members and 4 associate members for total of

1,013 members. During 2019 we created 34, restored 8, affiliated 1 and made 1 associate member for total of 44, however we lost 38 to suspension (NPD, requested or pre-req. body suspension), 1 demitted and 42 to death for total of 81 and a NET LOSS of 37, our membership as of December 31, 2019 was 967 regular and 5 associate for total of 972. Thanks to the hard work of our membership committee. Nobles please do your part to remain a member of Al Koran, if you are experiencing hardships please call the office and we will provide suggestions for dues payments, also be on the lookout for new members, petitions will be available on line. Requirements remain must be Master Mason in good standing.

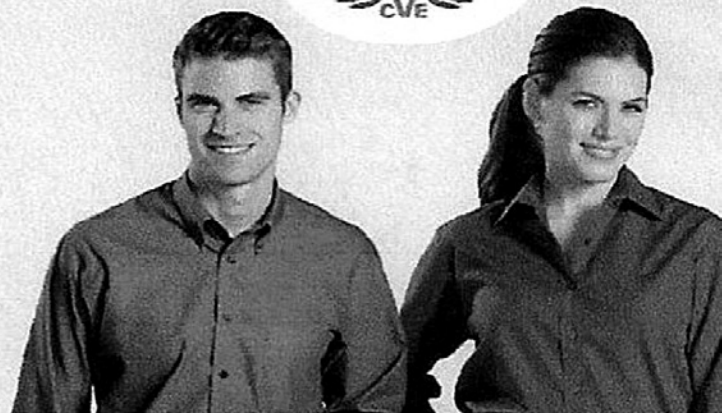
